Here's a secret, Cody: they have pushed me so far, even I don't know what I will do. I do know that if you make me take a strike or spend one more minute away from my life, my home, my daughter, you are adding insult to injury and this county will deserve whatever it gets after that. Before you assume that I am talking about violence, know this: I can cause more damage to this county without so much as breaking a law than many people could with an army. If all I do is show people what you have done to me, I promise there will be hell to pay. People like Flynn and the cops don't fear my ability to commit violence, they absolutely fear my political power to expose them. Just think about it, Cody. What do men like Flynn and these cops want more than anything? I mean anything. What keeps them awake at night? What is their deepest fear? It's simple, they fear the world seeing exactly how incompetent they are. ~~They fear being exposed~~

as the frightened little boys that they are. I'll tell you another secret: when they look at me, they know I'm not a boy like them. I don't dress up like a Super-hero in my hawaii 5-0 unders and go out and pretend I'm saving the world everyday. I never wanted to grow up to be a caricature of G.I. Joe or Kojak or Magnum F.I. I wear work-boots and I wear out a new \$150⁰⁰ pair every year. I have Callouses on my hands and I move mountains with hand-tools. I turn parcels of land nobody wants into beautiful, functional, places where people want to live. My Cabin at Whiskeytown would take your breath away. I have spent my entire life saying "yes sir" and "No sir" to little boys who knew in their hearts that I was already more man than they could ever be and do you think they ever once acknowledged that fact? No, Cody. That's part of who they are too. Real men aren't acknowledged, they are restrained and laughed at (but not too loudly because nobody wants a mouthful of calloused workman's fist). I'm warning you Cody. I'm warning you and I'm begging you at the same time: Don't put me on their level because I don't belong there. It will end badly. Not because of me. Because of them. You are about to stupidly fuck with elemental forces. If you let me out now with no strike, then I can go back to pretending they are better than me and that's the only safe place for someone like me. Once I am forced to become truly political, then the little boys of this world will descend on me like rats. I will spend the rest of my life fighting them. I just want to go home and be a father for Forest. Show me you have a fucking heart. Show me you are capable of true wisdom. Think about that precious little 4-year-old girl. Her entire life is in your hands right now you can send her father home to her battered and bruised right now but still able to fade back into the woodwork or you can send him home on the defensive and absolutely painted into a corner. A strike will alter the course of my life. Haven't you done ^{it} ~~enough~~ ~~before~~ already?

So you are aware, at 5 years with credit for my milestones (84 days) my out date would have been 12-18-2017. At 5 years 4 months with credit for my milestones, my out date would be 2-18-2018 (a month from now). Obviously, you'll never get me on a prison bus in a month, so either you add time to the plea or it will be a jail sentence. You should also be aware that if I continue to fight, you are looking at much more fight than you think. Irregardless of what hack lawyer I have, I am aware of my rights under the law. I will demand Flynn's recusal under 170.6 c.c.p. (cause-severe bias, violation of rights), I will demand a forensic (Not 13.68) psych exam. I guarantee you right now that a psych will say that 402 p.c. is completely against my nature, that it would take severe provocation, mental illness. That 9/11/2015 was a nervous breakdown caused by the cops and courts, that your system has terrorised me to the point of insanity and beyond. Cheri Dubuque will never testify. Not because she gives a damn about me, but because she does not want to be exposed in front of people as a child-molesting, pathologically lying whore. I have a right and will exercise the right to a traffic reconstruction expert who will prove that my driving on the buckhorn was not nearly as "reckless" as it has been portrayed. I will exercise my rights to pitchess motions on every single cop. When their records come back squeaky clean I will accuse the Sheriff's dept of sanitising and burying complaints (we both know they do it, too). I will exercise my rights to 995(b) motions and I have numerous grounds to get all four prelims re-done. I will make motions to dismiss for ineffective assist, outrageous part conduct, bias in the home-court, 14th Amend. (due process). Real scorched-earth shit, Cody. At best, you will get your strike but it will cost you another 100,000⁰⁰ in court cost and more because I will use all the exculpat^(91, 95, 96) info I ~~obtain~~ fight-

ing to prove my federal law-suit. That's right. your County will be paying for my fact-finding. I will also make the County taxi me back and forth to Siskiyou (where I will fight Siskiyou for incarcerating me illegally until you have to house me somewhere else). I've treated you with respect Cody (despite the fact that you have done everything you can to bully me). Respectfully, this may be our last chance to find middle ground. It's likely to be all up-hill after this. Offer me time served / no strike and we can just walk away. I won't even appeal. You win. And don't worry about Flynn being the fly in our ointment. You have all kinds of justification for offering me a fair plea. Psychiatric, in the interest of putting a long and contentious case to bed, to avoid further escalation of the dispute. Flynn will stand no chance if you and Ted Somers are on the same page. Or: we will recuse him for bias. So you are aware: I have written a lengthy and very sincere letter of apology to the officers and their families (admitting no guilt - apologising only for any misunderstanding - pledging that they have nothing to fear from me). If you agree to play fair - I will not only send it, but you have my word as a gentleman that I will show everyone in the Community that our dispute can be civilly resolved. We will start again with new perspective. Your heart is telling you what to do right now, Cody. It's okay to listen to it. It knows things your brain will never see.
