Yes, my home had very dangerous cliffs - Forest was never anywhere near them. Yes, my home had a shallow creek and we used to let Forest play in it while we supervised from no more than a few feet away.

According to her, she was always the victim. according to her, Forest often witnessed my "violent" behavior. I cannot possibly address or refute so many allegations. Can I? No less than Ernest Hemingway said, "the truth has a certain ring to it". Cheri's accusations do not ring true. Winston Churchill said "the truth is a precious thing because it is so often accompanied by the bodyguard of lies". Cheri is a master at taking some small truth and using it as a foundation for a monument of untruth. She absolutely buries me in lies until I can only tread water by constantly making denials. But then again, this is obviously her goal, isn't it? It's almost enough to make the Court ignore the fact that she is a Convicted, Violent, Felon, Violent, Sexual predator and Kidnapper. Soever, that this father is low-income and allowing cheri to move even a short-distance away will devastate the father-daughter relationship, that this father has not been in Forests life for three years and the Court should be encouraging a swift reunion and a strengthening of bonds at a time when they have been weakened, not using this fathers imminent release to justify placing additional and unnecessary obstacles in the way of the relationship. The Court should exercise wisdom and restraint and allow for the process to work itself out in due time, rather than be pressured and hurried into simply defaulting to mothers highly questionable demands. The court must be wise enough to recognise that it is not the mother who is truly in danger but Forests right to know the love and affection of her natural father. Ironically, this fathers impassioned argument is that the court not lose sight of the forest for the trees.

Whereas, this respondent and father does hereby respectfully move this Honorable Court, to replace Judge Jody M. Burgess with a more experienced Judge, more likely to recognise and avoid manipulation and uphold the rights of all parties including Forest H. Gibbs and Robert A. Gibbs, to deny at this time mothers attempts to relocate with Forest, to encourage re-unification with father and to temporarily stay all custodial matters until fathers release can facilitate mediation and a more fair and robust process.
