Dear Sir,

I am a defendant in Judge Flynn's courtroom. I am writing to you as Head Judge because I have witnessed severe bias and prejudgment by Judge Flynn as well as the prosecutor in my case and I am hereby requesting relief. I do not believe sir that I am getting fair treatment in Flynn's courtroom and I do not believe I will get a fair trial without outside intervention. Judge Flynn's actions are so egregious, unnecessary and overbearing that I am considering a suit alleging willful aggravation of my psychiatric condition. In the space of one hour I witnessed Judge Flynn violate nearly every right a defendant has including but not limited to: the right to see and confront witnesses, the right to be free from retaliatory action by government, the right to competent counsel, the right to a fair preliminary hearing, the right to be free from the false statements of so called witnesses, even and especially where they are law enforcement officers' own statements, the right to call my own witnesses, the right to insist and certify to the court that my lawyer is as prepared as humanly possible, or to refuse to certify that my lawyer is prepared because he isn't. Judge Flynn has suspended my license without cause, I will stand by what Flynn himself said his justification was, a non-reason, and it's on the record. I hereby ask that his order be immediately overturned and my license returned. Judge Flynn has also allowed the prosecutor to overcharge and in that light I am alleging bias and retaliation by the D.A. as they are aware of a federal civil rights action against the county alleging several civil rights violations by county and state employees. I also take great exception to the fact that Judge Flynn has allowed three separate cases to be combined thus making it harder to fight each one.

Judge Flynn is allowing Officers to lie under oath, has held me to answer for two felonies that I am not guilty of, has essentially set me up by neglecting to assign a lawyer until the last minute therefore assuring an unprepared lawyer. He did it despite my timely

and vehement objection in his courtroom. Also, Judge Flynn has shown how severe his bias is by the very atmosphere of his courtroom where he is allowed to rocket docket real human beings through the justice system, with a sadly insufficient admiration for a defendants civil rights or any real sense of the spirit of the law, thereby making defendants feel as though they do not have rights when in fact they do. I only feel scared and overwhelmed in Judge Flynn's court. The Judge is totally OK with me being completely off-balance. My claims of ineffective assistance of counsel are completely irrelevant to the judge. Being held to answer on such circumstantial, hotly debated and overcharged information, to a felony trial, all of these things are red flags to me and I hereby request relief, specifically recusal and a redrawing or complete dismissal of all charges.
