Dear Capt. Randall,

The law is not whatever you (or your deputies, or stephanie bridgett) decides it is. The law is the law. Your deputies failed to investigate fully the charges they arrested me for in 2015. They misapplied the law (422 p.c.) because it suited them at the time, or because they were ignorant of the meaning of the statute or for some other reason (possibly retaliation). Failure to investigate in a criminal case is a violation of the 6th amendment to the United States Constitution. When they (or you, or stephanie bridgett) decide they don't care if my right is violated, they are indifferent to civil rights. As elected officials, this is actionable under the law (meaning you can be sued). Every person, acting in an official capacity (such as yourself or the Shasta Board of Supervisors), who becomes aware of this violation and does not act to protect my civil right becomes a direct participant in that violation. I am further alleging, as you saw in my legal notice to the board of supervisors, a pattern and practice in Shasta county of failure to investigate (often deliberately) by Sheriff's deputies and District attorneys for the specific purpose of obtaining convictions (illegally or otherwise) in the superior court. This is a federal crime (conspiracy to violate civil rights). In my case stephanie bridgett went even further and maliciously prosecuted me in a retaliatory manner, which further eroded my rights and led directly to a coerced plea. This is also a federal crime (retaliation under color of law). Every person (such as the asst. deputy, district attorneys who prosecuted my case, my investigator, my lawyers, who failed to report this violation to either the federal or state department of justice is guilty of another federal law (misprision of a felony). My advice to you sir, is to investigate my claims fully and fairly and then immediately notify either the federal or state department of justice for prosecution of all of these individuals.

The Shasta County Board of Supervisors is hereby and again noticed that they have a legal duty to report these crimes and act immediately to protect and restore my civil rights. This obligation is separate from and in addition to the obligation of the courts, the Sheriff's department, the district attorney or anyone else. If county counsel, or anyone else tells the Sheriff's or the Board that they do not owe this obligation to protect my civil rights, then you all had better get better lawyers. You see, what all of you fail to recognize is that pointing the finger and saying it's someone else's
